Furthermore, CCF is recognized as an important step for designers preparing for AIFD certification.

### How to become a California Certified Florist

Applicants may pursue certification independently or be sponsored by an employer. Sponsored students who attain certification will automatically earn a certificate for their employer. Certification requires passing a one-day exam consisting of written and hands-on testing. If CSFA postpones or cancels your workshop or exam we will provide you with as much advance notice as reasonably possible under the circumstance. Once you are notified of a workshop cancellation, you have the right to reschedule or request a refund. Please keep this policy in mind as you make travel arrangements, as CSFA will not be liable for travel costs.

If you cancel a workshop or exam 7 days prior to class start: no charges incurred. If you cancel 6 days or fewer prior to class start: you will be charged 100% of the class fee. If you register during the cancellation period, the policy is in effect immediately. If you are registered in a workshop and fail to attend, you will be charged 100% of the class fee.
